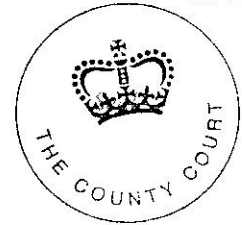

IT IS ORDERED THAT

1. Jeffrey Matthews (the Proposed Defendant) by himself, his servants, agents or otherwise whosoever be restrained from withdrawing funds held by Cardiff city Council howsoever, for the sale of the proposed Defendant's former property at 8 Castle Road Cardiff and/or the Nationwide Building Society to the sum of £20,000.00 until further order of this Honourable Court.
2. Cardiff City Council by itself, its servants, agents or otherwise whosoever be restrained from paying Jeffrey Matthews (the proposed Defendant) from funds held by it howsoever, as a result of the sale of the Defendant's former property at 8 Castle Road Cardiff to the sum of £20,000.00 until further order of this Honourable Court.
3. Nationwide Building Society by itself, its servants, agents or otherwise whosoever be restrained from paying Jeffrey Matthews (the proposed Defendant) howsoever, from the account balance held by it to the credit in the Defendant's account number 2025378 sort code 07 02 46 to the sum of £20,000.00 until further order of this Honourable Court.
4. The Claimant undertakes to issue the Claim Form exhibited hereto in the County Court Business Centre after the further *inter partes* hearing.

5. The Claimant undertakes to this Honourable Court to pay any damages that will be sustained by Jeffrey Matthews (the proposed Defendant), Cardiff City Council and Nationwide Building Society as a result of the grant of the Interim freezing orders granted herein.
