Hi Rosie

I am sorry I have not responded to you earlier, but I have only just been able to return to my office.

The problem we have with Mr Kirk having his documents in his pocession is that he currently has about 20 files for the criminal case he is defending himself.

He has recently managed to accidentally set a fire in his cell, which although it was not serious, it could have been a whole lot worse with the extra paperwork in his cell. The fire marshall is not happy with the current amount of paperwork that he has in his cell without adding a further 20 files. I am very concerned that should he having another incident of this nature it may be more serious next time. Added to this he appears to be forgetting things very easily, hence the fire was because he forgot to extinguish a cigarette before he placed it in a waste bin.

Thank you for your response to His Honour Judge Seys Llewellyn Q.C.'s enquiry regarding Mr Kirk dated 1st March 2012.

As you have probably been made aware by Joanne Morgan, (who has assisted greatly in keeping the Court informed of matters concerning Mr Kirk), he is due to appear in Court tomorrow regarding his forthcoming civil trial.

I have been asked to contact you again in response to your letter by His Honour.
